That on 29/11/2021 at around 1117 hrs received credible source information stating that one Roshan Gupta, r/o Housing Colony, Nayabazar, West Sikkim is in possession of contraband/psychotropic substances and that he has kept it in his room.

Considering the urgency of matter, self along with Police team immediately rushed to the above mentioned address for enquiry wherein the above named accused person was found alone in his room. I examined him and strongly suspected to be in possession of contraband substances. Accordingly, an option was given to him u/s 24 (1) of SADA, 2006 and Sec. 50 of NDPS Act, 1985 for search of person and his room in presence of two independent witnesses namely Sanjay Kumar Gupta and Shivaji P. Gupta both r/o Nayabazar, West Sikkim wherein he preferred to be searched in the presence of Gazetted Officer. Service of Shri, Mahindra Pradhan, SDPO/Soreng was availed for the said purpose. The above-named accused person was searched in the presence of Shri, Mahindra Pradhan, SDPO/ Soreng and two independent witnesses wherein following items were recovered from his possession:

1. Cash Amounting to Rs. 4,100/- (Marked Exhibit A)

2. One Pipa made from Rs. 20/- note and one pink colour lighter. (Marked Exhibit B)

The above-mentioned exhibits were seized, packed, sealed and labelled in the immediate presence of Shri, Mahindra Pradhan, SDPO/ Soreng and two independent witnesses.

The room of the accused Roshan Gupta was also searched u/s 100 CrPC wherein the following items were recovered:

1. One blue colour Redmi mobile phone and one silver foil. (Marked Exhibit C)

2. One small polybag containing 03 pouches of wet brown powder (suspected to be Brown sugar) weighing 1.09 grams (Marked Exhibit D)

3. One black colour polybag containing blue capsules (Winspasma) 361 nos. (Marked Exhibit E)

4. One white colour polybag containing 62 nos. Nitrosun 10 tablets concealed inside white bag. (Marked Exhibit F)

5. Weed (marijuana) weighing 9.13 grams wrapped in a white polybag and red bag. (Marked Exhibit G)

Accordingly, the said items were seized as case exhibits and packed and sealed in presence of two independent witnesses.

On the basis of above facts and seizure Nayabazar PS Case no. 21/2021, dated 29/11/2021, u/s 9(b), (d), 14 of SADA Act, 2006, r/w Sec. 9 (1) (b) SADA Amendment Act, 2017, Sec 22/27 of NDPS Act 1985 registered on suo moto basis against Roshan Gupta, age 28 yrs, s/o Krishna Kumar Gupta, r/o Housing Colony South Sikkim and endorsed to SI Rinzing Dorjee Lepcha for further investigation.

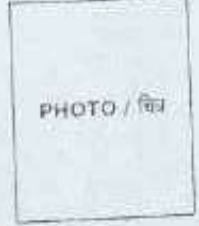
