Respected Madam,

In pursuance of enquiry trusted on me regarding an information received from Arun Tamang @ Ashang s/o Jalipool informing that one handy boy (helper) of vehicle bearing reg. No. SK-01-D-3161 was set on fire by some miscreants at Murda Hathi Jalipool. I submit my enquiry report as under :-

That on 1900hrs on the same day i.e. 21.03.2021 two persons namely Bishal Gurung, 31 yrs s/o Ram Abd Gurung s/o Jalipool and Satish Rai, 31 yrs s/o Jalipool, East Sikkim had a verbal confrontation with the victim Pawan Sharma, 20 yrs s/o Raju Sharma s/o Central Pandam, East Sikkim. The situation got heated up and the duo i.e. Satish Rai & Bishal Gurung who were inside the vehicle bearing reg. No. SK-01-D-3161 with the victim Pawan Sharma, found a bottle of diesel under the seat of the vehicle. Satish Rai poured the whole bottle of diesel on the victim and Bishal Gurung lid the victim and was set into fire. Engulfed with fire the victim quickly forced himself out of the vehicle and screamed for help. When nearby people saw the victim they quickly extinguished the fire which was set by the duo persons and immediately evacuated the victim to CHH Manipal for medical aid.
