12. FIR Contents:

That on 01/02/2021 at around 1912 hrs received telephonic information from HC Natra Prasad Chettri, Incharge/Reshi Police Out Post stating that during Nakabandi, one person named Prayash Chettri, age 29 yrs, s/o Shri. Tulshi Pd. Chettri, r/o Tingmoo, South Sikkim was suspected to be in possession of drugs (contraband substances) and is reportedly detained at Reshi OP along with his vehicle bearing registration no. SK 04 J 1172.

I, therefore, rushed to Reshi immediately and conducted enquiry. I found the above named suspected person in Reshi OP and the vehicle bearing registration no. SK 04 J 1172 outside Reshi OP. I examined him and strongly suspected to be in possession of contraband substances. An option was given to him u/s 24 SADA, 2006 for search of his person and vehicle. The above named suspected person preferred to be searched by gazetted police officer. Accordingly, service of Shri. Mahindra Pradhan, SDPO/Soreng was availed who arrived at Reshi OP around 2100 Hrs dated, 01.02.2021. The above named suspected person was therefore searched in the presence of Shri. Mahindra Pradhan, SDPO/ Soreng and two independent witnesses of the locality namely 1. Shri. Passang Tamang, r/o Reshi, West Sikkim and 2. Shri. Bhagat Rana, r/o Reshi, West Sikkim.

Before the search, the search team submitted before the suspected person for their body search duly preparing a memorandum of search. The search of above named suspected person was therefore conducted duly fulfilling lawful norms and to his satisfaction in the presence of independent witnesses wherein following contraband/psychotropic substances were recovered from his possession and his vehicle bearing registration no. SK 04 J 1172 (Bolero):-

1. Winspasma capsules: 02 file containing, 12 nos. of capsules (bearing batch no. WPS 19026 manufactured Sep 2019 expired- Aug 2021).

2. Nitrosun 10 tablets: 05 tablets (bearing batch no. AB 94491 manufactured 10/2020 expired- 5/2023).

3. Cash amounting -

(a) Rs. 500*5= Rs.2500/-

(b) Rs. 200*2= Rs.400/-

(c) Rs. 100* 6= Rs. 600/-

(d) Rs. 50*7= Rs. 350/-

Total Rs. 3850/-

4. One Samsung mobile phone.

5. One black leather wallet printed "MOTOR HARLEY DAVIDSON CYCLES 100".

6. From vehicle bearing reg. no. SK 04 J 1172, 10 files of Winspasma capsules containing, 100 nos. of capsules (bearing batch no. WPS19026 manufactured Sep. 2019 exp. Aug. 2021) were recovered under the foot mat of passenger front seat.

The above mentioned exhibits were seized, packed, sealed and labelled in the immediate presence of Shri. Mahindra Pradhan, SDPO/ Soreng and two independent witnesses.


On the basis of above facts and seizure Nayabazar PS case no. 03/2021, dated 01/02/2021, u/s 9(b), (d), 14 of SADA Act, 2006, r/w Sec. 9 (1) (b) SADA Amendment Act, 2017 registered on suo moto basis against Prayash Chettri, age 29 yrs, s/o Shri, Tulshi Pd. Chettri, r/o Tingmoo, South Sikkim and endorsed to SI Rinzing Dorjee Lepcha for through investigation.

13. Action taken: Since the above report reveals commission of offence(s) vide Entry No. 2, the case is registered and investigation is taken up/directed* SI Rinzing Dorjee Lepcha to take up the investigation/transferred to PS _____ on account of jurisdiction.
