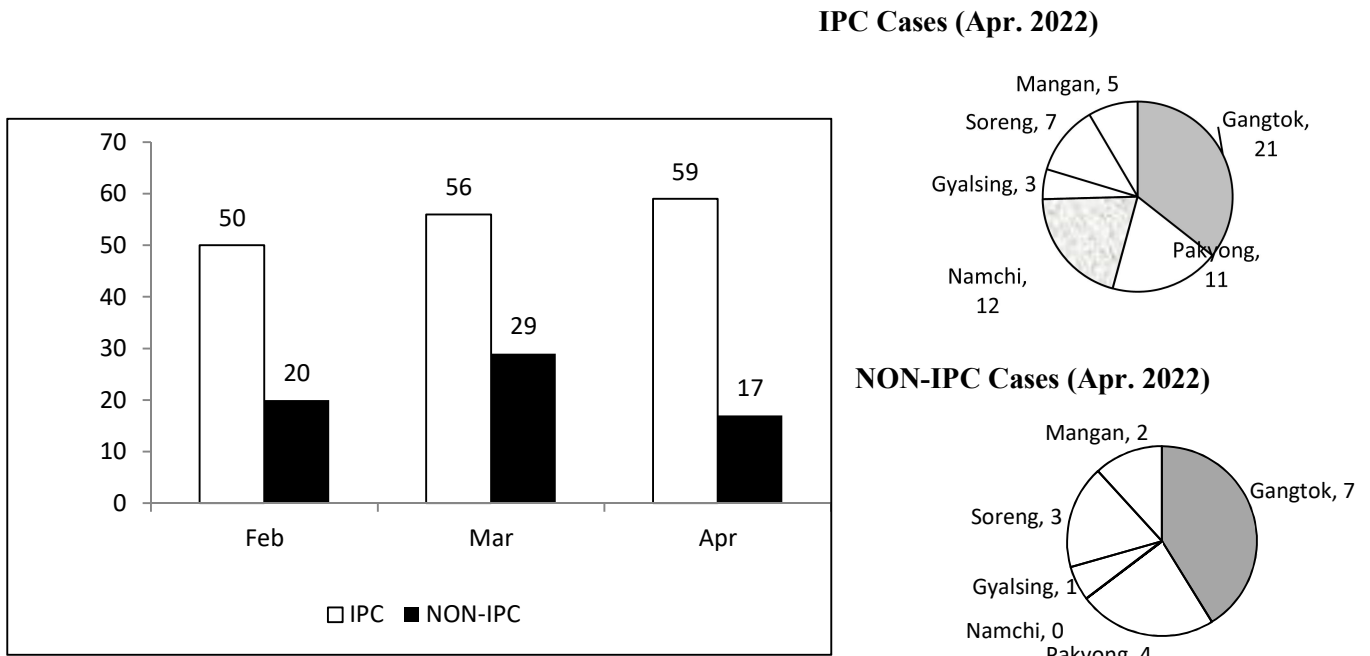


**MONTHLY CRIME REVIEW FOR THE MONTH OF APRIL-2022**

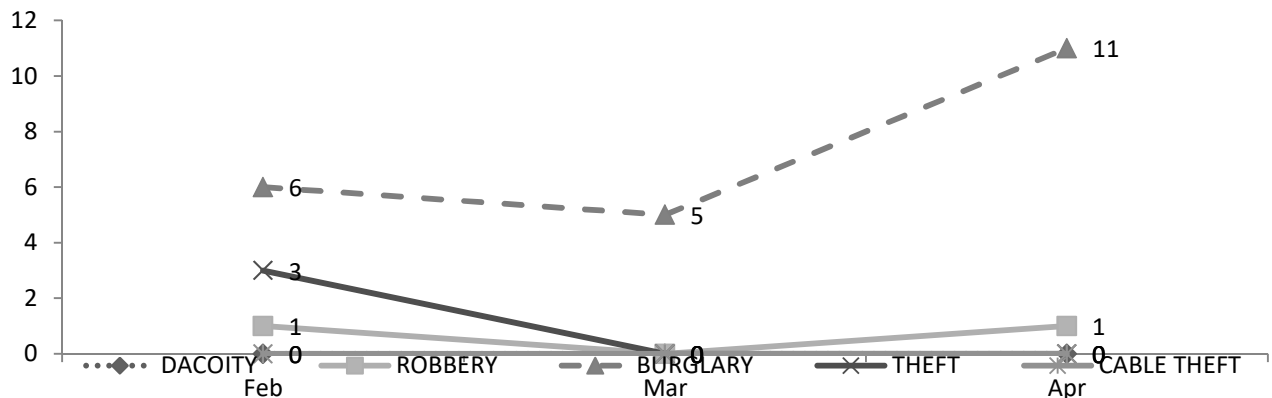
1. **TOTAL CRIME:** During the month of **April 2022** **59** IPC and **17** Non-IPC cases were registered to show a decrease in cases as compared to **March 2022** as depicted in figure 'A' below. District wise IPC and Non-IPC cases are shown in the two pie charts below:-

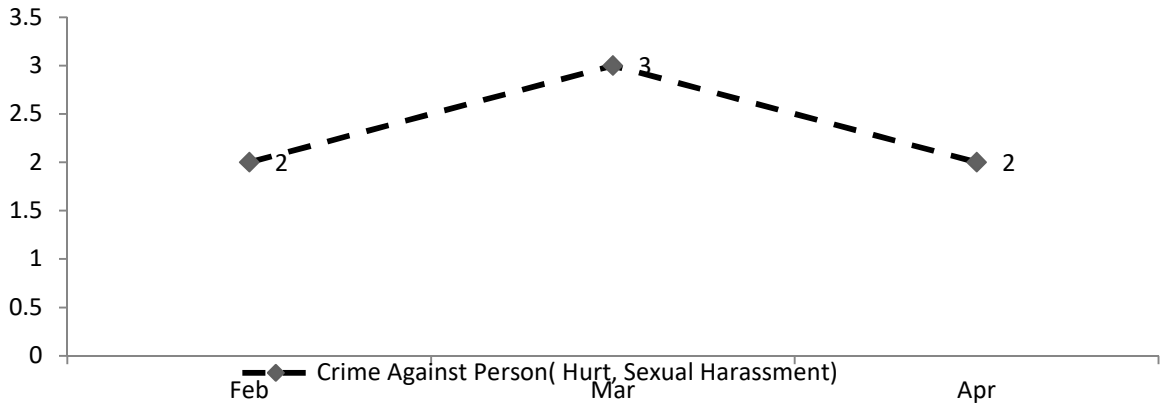


2. **PROPERTY CRIME AND CRIME AGAINST PERSONS :**

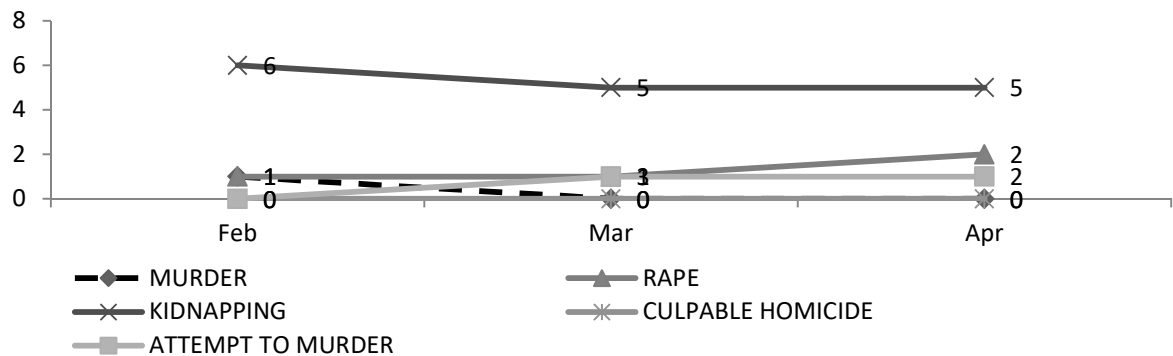
As seen in the chart below cases under the head Property Crime **12** cases were registered in the month of **April 2022** as **05** cases was registered in **March 2022** and **10** cases in **February 2022** respectively.



A. As seen in the chart below **02** cases under the head “GRIEVOUS HURT” & Sexual Harassment were registered in the month of **April 2022**, as **03** cases was registered in **March 2022** and **01** cases in **February 2022** respectively.

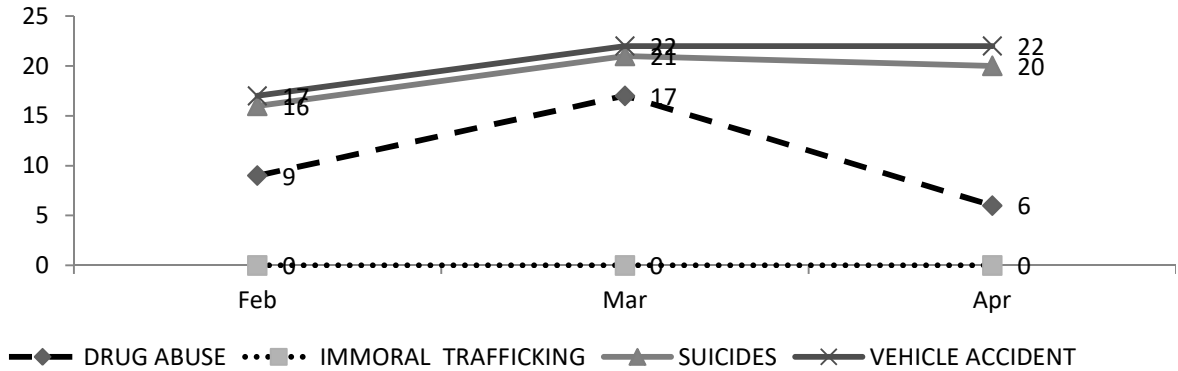


3. **HEINOUS CRIME** (Murders, Culpable Homicide, Attempt to Murder, Rape, and Kidnapping): The total number of heinous cases during **April 2022** is **09** which are equal as compared to the previous month.



4. **PROFESSIONAL CRIME** (Receiving Stolen Property, Breach of Trust, Cheating, FICN & Kidnapping for Ransom **02** case under **Cheating** and Breach of Trust registered during the month under review.

5. **STATE PREVALENT CRIME/INCIDENTS** (Immoral Trafficking, Drug Abuse, and Vehicle Accidents & Suicides): The total number of State Prevalent Crime/Incidents registered during the month of **April 2022** is **48** which show a decrease of cases in **Drug Abuse, Vehicle Accidents & Suicides** as compared to previous month.



6. **NEW AGE CRIME /CYBER CRIME:** 03 cases were registered during the month of April 2022.

7. **CRIME ANALYSIS:** Crime Statistics indicate a decreasing trend as compared to the previous month.

8. **FOREIGNERS ACT CASES:** - No case was registered under the foreigner's act.

9. **INVESTIGATION PROGRESS:** All the cases registered during the month are under investigation.
